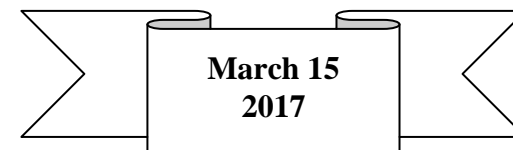

THESIS**

Accepted materials up to 2 pages A5 typed in Microsoft Word as a computer file with the extension * doc. or * rtf. Font Times New Roman Cyr 10. Spacing interval - single. Paragraph - 0,5 cm. Fields from all sides by 1.5 cm. The heading of abstracts should contain the following data:

- initials and surname of the author (s), the name of the organization where the author (s) works (equalization on the right edge);
- name of theses (in capital letters), (Times New Roman Cyr 9, center alignment);
- the main content of abstracts;
- a list of literature (not necessarily).
- Students must indicate the scientific supervisor (at the end of thesis).

The file name must match the first co-author's name.

Language of the report: Ukrainian, Russian, English, Polish.

Participation forms:

- full-time: report (up to 10 minutes); message (up to 5 minutes);
- part-time.
